NOTIFICATION

In exercise of the powers conferred by Section 3 of the Essential Commodities Act 1955 and sub clause of 1(3) of the Kerosene (Restriction on use and Fixation of Ceiling Price) Order, 1993 Central Order dated: 02.09.1993 published in GSR (E) in part II, Section 3, sub section (i) of Gazette of India, extraordinary No.300 dated 02.09.1993, the Central Government or State Government may by an Order permit any person to use kerosene for such other purposes as specified.
